

OUR COMMITMENT TO SAFEGUARDING

At Stanley Park Junior School we believe that all children and young people should not experience abuse of any kind. We have the responsibility to promote the welfare of all children and young people and to keep them safe at all times when in our care. We are committed to our responsibilities in a way that protects them.

The governors, staff, parents and volunteers are committed to safeguarding and promoting the welfare of our pupils; it is of the utmost importance. This statement is to be read alongside our Child Protection Policy and safeguarding procedures.

We listen to our pupils and take seriously what they tell us. All school staff are trained in Child Protection, and children are made aware of the adults they can talk to if they have any concerns. Staff are trained to look out for signs of physical/emotional harm or neglect and are required to report these to the Designated Safeguarding Lead (DSL).

The Purpose of this Statement is:

- To protect all children and young people in this school.
- To provide all staff with the overarching principles to safeguarding and child protection expected in this school community.

We recognise that:

- The welfare of the child is paramount as enshrined in the Children's Act 1989
- All children regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity have a right to equal protection from all types of harm or abuse.
- Some children and young people are additionally vulnerable because of the impact of previous experiences, their level of dependency, communication needs or other issues
- Working in partnership with children, young people, their families, carers and other agencies is essential in promoting their welfare.

Safeguarding covers more than child protection issues so we also have a number of related policies and practices.

We will seek to keep children and young people safe by:

- Having a robust <u>Child Protection and Safeguarding Policy and procedures</u> in place which are regularly reviewed. (You are encouraged to read the policy on our website <u>www.spjs.org</u>)
- Having a staff code of conduct booklet for all staff and volunteers
- Developing and implementing an effective health and safety policy and related procedures that are regularly updated.
- Having an anti-bullying policy (available on our website)
- Teaching pupils about <u>child protection and e-safety issues within the PSCHE</u>, science and <u>Computing</u> part of the curriculum and assemblies. We aim to develop their skills to keep themselves safe, online and in the real world.
- Encouraging our pupils to have a "sense of pride" in what they do and that includes how they behave. We have high expectations of courtesy, tolerance and mutual respect.
- Maintaining a safe learning environment at school, so that pupils feel secure and we provide emotional support in school, with parental consent, if worries are identified.
- Valuing, listening to and respecting children.
- Sharing information about safeguarding, child protection and good practice with children, young people, families, carers, staff, governors and volunteers
- Recruiting staff and volunteers following 'safer recruitment procedures' and ensuring that all the necessary safeguarding checks are completed.

It is rare that concerns are raised which require the involvement of external agencies. Sometimes we may need to share information and work in partnership with other agencies when there are concerns about a child's welfare. We will ensure that our concerns about our pupils are discussed with his/her parents/carers first unless we have reason to believe that such a move would be contrary to the child's welfare.

Our nominated governor for child protection is Sara Rowe who is also Chair the Governing Body's Safeguarding Working group.
